TERMS & CONDITIONS OF MEMBERSHIP

1. Any person wishing to become a member of the Golf Club must submit a completed application form, together with the appropriate payment, to the Club Secretary. A direct debit option is available which carries an additional administration charge (currently £60 pa). This amount is included in the monthly payments.
2. Membership fees are due on the 1st May. Anyone joining during the year will pay the appropriate membership fee pro rata.
3. Priority for membership renewal will be given to existing members of the Club.
4. The Club retains the absolute right to reject any application for membership or refuse to continue with or renew any membership.
5. Failure to pay the annual subscription fee by the due date will result in the membership ceasing. Non-payment on the due date may be treated as a cancellation notice.
6. It is the responsibility of members paying by monthly direct debit to ensure that their monthly payments are made on time and are kept up to date. Should any direct debit be unpaid, the person's playing membership will be suspended after 1 month (2 Lapsed Payments) and until all outstanding amounts have been paid. Failure to pay by direct debit for 3 months will result in the membership being permanently cancelled and will not be renewed until past dues are bought up to date.
7. A new membership is a 12 month agreement whether paid in one amount or by monthly direct debit. Any member paying by direct debit who cancels during the first 12 months and then wishes to re-join at a later date during that same year, or wishes to join during any subsequent years, must pay all of the outstanding payments due in the year.
8. A member who has completed 12 months may resign at any time. They may rejoin after a minimum of 9 months. If they have paid by annual fee they will receive a pro rata credit for any amounts due when they rejoin. They may only take advantage of this clause once in their membership of the club.
9. Should a member become medically unfit then from when they notify the Club Secretary and provide documentary evidence of their condition their direct debit payment will be suspended for the period of their incapacity, or, if paying annually a future period of grace will be given against their annual payment when they return to play.
9. The management reserve the right to refuse admission and/or cancel membership of any member, who, in the opinion of the management, causes nuisance or annoyance to other members, or, their guests, visitors or other users of the club facilities or hotel.
10. Each member will be issued with a membership card, which is non-transferrable. The number on the card will incorporate the individual membership number and must be produced in the hotel in order to obtain members' discount.
11. Members are responsible for their guests at all times
12. Members must strictly adhere to the booking system in force at all times.
13. Corporate members are not permitted to play in Club competitions and are not eligible for handicap administration.
14. Direct debits from corporate members must come from one account and a VAT number must be provided upon application.
15. All members of the Whitefields must comply with the Constitution of the Club, the local course and competition rules.
